#### FROM THE SUB-DEAN, PEGGY GRAFF




Summer greetings, FWAGO!

#### **TREASURER'S REPORT**

As of May 31, 2020, the chapter's current net worth (assets, including receivables pending deposit by AGO HQ, less liabilities) is \$75,736.19. Our Comerica Bank checking account balance is \$26,065.28, but \$10,822.55 of that balance is RESTRICTED for use only by the William E. Hayes Scholarship project, leaving an UNRESTRICTED balance of \$15,242.73. Our Comerica Bank savings account balance (all unrestricted funds) is \$47,710.91.
